## Purpose of the Job:

Provide a complete range of social, physical and personal care to older people that are living with dementia or frailty, promoting independence at all times.

## Main duties and responsibilities:

- 1. Deliver personal care and emotional support to people we support that are staying on the units.
- 2. Support people we support to regain their independent living skills by working in a way that promotes independence and by implementing plans set by OTs and physiotherapists.
- 3. Encouraging people, we support to participate in activities on the unit, and deliver 1:1 activities with people if they prefer that.
- 4. Keep clear, understandable and succinct care records, and notify the Team Leader of any concerns they have about people we support.
- 5. Be responsible for reporting any safeguarding concerns to the Team Leader and act in accordance with our policy & local procedure.
- 6. Attend regular one-to-one meetings, team meetings, and training courses, and ensure mandatory training is in date at all times.
- 7. Support the Team Leader to deliver a safe and effective service.
- 8. Ensure that requirements of current national guidance are being met and delivered in line with the regulator of the service
- 9. Promote inclusivity, embrace diversity and ensure equality and ensure that people we support are at the centre of their care at all times.
