## Purpose of the Job:

To lead and direct the Calibration Section, ensuring performance accords with business plan targets and clients' requirements. Undertake the role of Calibration Technical Manager as required by UKAS. Line manage the section staff in accordance with KCC's policies and procedures.

## Main duties and responsibilities:

- 1. Manage the section to ensure safe, efficient and effective service delivery.
- 2. Manage the calibration staff, develop their skills and motivate in order to deliver a continually improving service.
- 3. Ensure the effective management of all resources of the calibration section.
- 4. Contribute to the development and improvement of KSS by working as part of the management team.
- 5. Undertake the role of calibration technical manager as required by UKAS to ensure effective standards and accreditation are maintained.
- 6. Ensure the County Standards and all weighing and measuring equipment are maintained to the levels required by statute and by UKAS to ensure business credibility is maintained.
- 7. Develop and maintain operating procedures to ensure service delivery complies with client requirements, UKAS standards, business plan targets and the requirements of metrology legislation.
- 8. Manage and ensure the delivery of client contracts, including local authority contracts, section 101 agreements, management of inventories etc.
- 9. Proactively seek out opportunities to increase income for the section, including opportunities to deliver new services and to attract new clients.
- 10. Develop and maintain relationships with clients, undertaking regular review meetings with major clients as necessary and resolve any problems arising.
- 11. Develop and continuously improve systems to improve the efficiency and effectiveness of the section. Develop the calibration section's range of services to attract new clients and new income.
