## Purpose of the Job:

The post holder will be responsible for supporting the development of effective and evidence-based public health information activity. They will provide input into the process of understanding health needs in the area, addressing health inequalities, determining priorities for action, assisting wider understanding of the characteristics of the local population and actively disseminating the findings of a wide range of analyses.

They will provide support to Senior Intelligence Analysts across a number of projects including health needs assessment, equity audits, data retrieval and data maintenance. The post holder will possess good numeracy and English skills as well as being a good communicator. They will provide specialised advice on health intelligence and health data sets, using statistical thinking.

## Main duties and responsibilities:

- Be a resource for data analysis, interpretation and presentation, utilising spreadsheets, maps and analytical tools across a wide range of data sets
- Provide analysis and interpretation in response to external requests for information
- Ensure good communication and relationships with internal and external stakeholders.
- Ability to manage several projects and able to manage time effectively.
- Ability to be flexible and respond effectively according to the requirement of the service
- Provide help, advice or information on health intelligence issues including the development and analysis of health-related data sets and information including analytical methodology.
- Maintain and quality assure the health and social care maps.
- Promote public health methodologies to support other public health professionals locally and regionally.

- Some reports will require communication of complex statistical analyses and concepts, and it will be necessary to be able to explain such analyses and findings to specialist and non-specialist audiences in a way that they can understand the implications and the inferences arising from the analyses within the report.
- Ability to travel to meet the requirements of the service
- Commitment to equalities and the promotion of diversity in all aspects of working
