- Ensure the vehicle is fit for the road by undertaking and logging daily routine checks pf lights, tyres, oil, water etc., reporting any defects, to maintain the safety of the driver and goods.
- Ensure the vehicle is loaded safely, manually handling and storing all deliveries to make the most efficient use of the vehicle, for optimum efficiency and safety.
- Drive in accordance with the Highway Code regulations, and take responsibility for the vehicle, including security and the completion of paperwork to provide a safe and efficient service.
- Maintain a clean vehicle both inside and out to provide a clean environment for users of the vehicle.
- Maintain the security of all unstaffed buildings after deliveries and collections have been made, by keeping keys and security codes secure and locking buildings, to ensure the security of buildings.
- Display active commitment to a customer focused service by placing the customer at every aspect of the work, engaging with internal customers in a friendly, helpful manner and achieving the best possible outcome for the customer.
