Job Description: Public Health Senior Project Officer (Suicide Prevention and Public Mental Health)

Purpose of the Job:

This position plays a vital role in delivering outcomes within the very small but nationally influential Suicide Prevention Team based within KCC's Public Health Team.

It is anticipated that there will be four particular projects that this role will focus on during the 12-month contract.

- 1. Design, deliver and evaluate interventions (including research) to improve wellbeing, and reduce the risk of self-harm and suicide amongst people impacted by domestic abuse.
- 2. Design, deliver and evaluate interventions (including research) to improve wellbeing, and reduce the risk of self-harm and suicide amongst people in financial difficulty.
- 3. Project manage the Real Time Suicide Surveillance System with Kent Police.
- 4. Project manage the Kent and Medway Better Mental Health Network including overseeing Kent and Medway's application to become a signatory to the National Prevention Concordat for Better Mental Health.

However, this role is within a very small team and there will be a need to be flexible and respond to emerging trends and issues, as well as helping out with practical tasks such as event management and meeting administration.

Main duties and responsibilities:

- Design and manage a range of projects across the Public Mental Health and Suicide Prevention Programmes (and within a multi-agency context at all stages of the project cycle), including pre-assessment, project initiation, planning, management of project dependencies, development of sustainability plan, assisting in the project closure and lessons learned reports.
- 2. Monitor and evaluate the progress of the projects, identifying any scope for improvement and addressing any problems or constraints.
- 3. Undertake research to develop specialist knowledge of relevant issues, and initiatives related to high-risk groups.
- 4. Monitor and support any relevant commissioning activity, as agreed with partners, in order to ensure that overall project objectives are met.

- 5. Maintain regular and effective communication with stakeholders (at all levels), including recommendations and reports on projects to ensure that informed decisionmaking takes place.
- 6. Provide support to the Public Mental Health (Suicide Prevention) Programme Manager in the planning and monitoring of project budgets to ensure tight financial control and the effective use of resources.
- 7. Develop and implement contingency plans so that any services affected by the project can continue to be provided if the original plan does not meet particular timescales.
- 8. Promote the Public Mental Health and Suicide Prevention Programme within KCC and across partnership agencies at a strategic level.
