Job Description: LDA Practice Co-Ordinator - Complex Care (Senior

Practitioner)

## Purpose of the Job:

The LDA (Learning Disability and/or Autism) Practice Co-Ordinator - Complex Care is an exciting new role funded by NHSE England and hosted by Kent County Council, to work across the Kent and Medway Clinical Commissioning Group footprint.

Across the system in Kent and Medway we are passionate about promoting good mental health and wellbeing for children and young people with Learning Disabilities and/or Autism. We strive to use the expertise and resources within our organisations and through our partnerships to deliver high quality services that are safe and focused on children and young people's wellbeing and recovery. Our first two LDA Practice Co-Ordinators started in March 2021 and we are now recruiting a further two roles to ensure we can support children and young people with Learning Disabilities and/or Autism (LD/A) and their families, as detailed in the NHS Ten Year Plan.

This role is designed for an experienced practitioner who wants to engage their full skill and knowledge set and stretch their abilities into a more strategic arena.

Secondment to this post from an existing job may be able to be considered.

## Main duties and responsibilities:

- Although not case holding, the role will offer a rewarding combination of supporting the
  multi-disciplinary team who are working at an individual level, focusing on preventing and
  minimising stays in children's specialist mental health hospitals and assessment and
  treatment units, as well as engaging at a more strategic level working with health,
  education and social care teams and managers.
- The LDA Practice Co-Ordinator Complex Care will offer expert advice and guidance to teams on meeting the needs of the child or young person during discharge planning and co-ordinating discharge at a timely pace. Being child, young person (CYP) and familyfocused is an expectation that brings responsibility for maintaining a close relationship between the post holder and the CYP's parents or carers.
- Delivery of the role should provide assurance that there is development of an effective community care pathway in place upon a CYP's discharge and to reduce further admissions. The post holder will be required to support multi-agency teams and managers across Kent, working with services who hold responsibility for duty of care towards CYP with LDA, including offering consultation to avoid admission in the first place. The LDA Practice Co-Ordinator - Complex Care is not expected to carry an individual caseload.

- The post holder is expected to build strong relationships with external stakeholders such as Tier 4 providers and NHSE to facilitate effective joint working between the Local Authority, CCG and their partner organisations.
- There will be a need to ensure close working links with the Care Education Treatment Review (CETR) team to identify CYP at high risk for admission, using the local Dynamic Support Register, and for CYP already identified to build a triangulated care picture that ensures progression of CETR recommendations, and is able to inform Commissioners about gaps and risk in the community care provision.
- The post holder will contribute to existing reporting systems, adapting reporting tools to best deliver the key data required to support transformational change across agencies to improve the experience and outcomes for CYP with LD/A and their families.
- The post holder will be required to maintain an awareness of changes in legislation, theories, corporate and directorate policies, local and multi-agency practices relating to CYP with LDA to contribute to the delivery of a high standard of service.
- The team will cover the whole of Kent and Medway, with each LDA Practice CoOrdinator taking a lead across a specified area, but able to be flexible to provide support wherever it is required.
- Individual supervision will be provided by the Senior Commissioning Manager in KCC, who
  is leading the Designated Keyworker Early Adopter Project, with additional group clinical
  support from the Senior Commissioner (LDA), Kent and Medway CCG.
