Job Description: *Active Travel Project Officer*

Purpose of the Job:

The post holder will champion the development, promotion and co-ordination of active travel strategies and infrastructure in Kent. They will work with a wide range of partners and stakeholders to expand, link up and deliver improved safety standards across the county's active travel network including the cycle network. Key outcomes are to increase the frequency and number of people actively travelling, improve road safety, support sustainable development, tackle congestion and pollution and contribute to wider active travel and public health objectives.

Main duties and responsibilities:

1. Develop KCC strategies and standards to ensure design and maintenance of cycling, walking and wheeling infrastructure is to the highest standard possible. The postholder will also ensure this work is in line with the Local Transport Plan, the Active Travel Strategy, Vision Zero and the Energy and Low Emissions Strategy.
2. Support the implementation and review of district / borough cycling and walking strategies, related strategies and Local Plans to facilitate sustainable development within the planning application process and improve local active travel networks by identifying improvements and missing links.
3. Identify research, innovation and best practice from within and beyond the county to develop new active travel initiatives and promote this through organising technical notes, workshops and presentations.
4. Improve the mapping of cycle network information in Kent and support changes to the way that cycle mapping data is maintained and shared to improve the overall maintenance of the network. Assist with improving the public reporting of faults on the network.
5. Understand and assist with KCC cycle counter contract, ensuring data received is reliable and that it is analysed, used and shared widely with partners and investigate further opportunities to gather active travel data.
6. Act as the initial point of contact for general cycle and walking infrastructure customer enquiries and as the KCC contact for local active travel interest groups in Kent. Respond to and engage with County, District/Borough, and Parish councillors when required.
7. Co-ordinate work with other County Council directorates, with district councils, police, public health, schools, businesses, transport operators, local community groups and other agencies to ensure best use of resources and joined up actions.

8. Understand and assist with the Monitoring and Evaluation process of projects from inception through to completion. Monitor key indicators and report progress against targets.
9. Assist with implementing Highway active travel schemes including consultation, Equality Impact Assessments, landowner negotiation, technical specification and legal agreements. Assist with the processing for new Cycle Track Orders and permissive cycle route agreements, including the transfer of Sustrans legal agreements.
10. Seek funding from external sources including developers, and national and EU programmes in order to enhance the Kent active travel network and deliver work to budget.
11. Support and advise other Highways and Transportation teams on active travel aspects of their projects and identify synergies. Including Public Transport, Transport and Development, Major Projects, and Public Rights of Way.
12. Support wider Road Safety and Active Travel projects when required by the Countywide Programme Manager (Active Travel) Programme Manager.
