Purpose of the Job:

Provide 'Expert by Experience' professional support to the following programmes of work:

- 1. Designated Key Worker Programme,
- 2. The Neuro Developmental Assessment Pathway and
- 3. The Children and Young People's Crisis and Complex Care Programme.

Using own experience and that of other families in consideration of key aspects of these programmes, ensuring the programmes are taking a family centric approach in their development, delivery and that information regarding each programme is co-produced and accessible.

Undertaking project activities that contribute towards the smooth running of these programmes, in support of compliance and consistency with NHS England's guidelines, legislative requirements and KCC Policy.

Contribute to and co-ordinate the collation of information relating to performance indicators and other management information required within the programmes.

Main duties and responsibilities:

- 1. Provide 'Expert by Experience' support from a family/carer perspective to key areas of the three programmes as listed above. (Definition of 'Expert by Experience' included below)
- 2. Attend a range of strategic meetings in relation to the three programmes and advocate for the needs of children, young people and their families.
- 3. Be key liaison person with Designated Key Worker Programmes Co-production Partner.
- 4. Plan, organise and coordinate internal and external meetings, preparing agendas and recording actions, and undertaking research where required, ensuring that the voice of families is represented within all three programmes.

- 5. Support and / or lead on the delivery of presentations and help facilitate interactive workshops to a variety of audiences, using a variety of tools and techniques.
- 6. Research, coordinate, collect and analyse data both quantitative and qualitative. Creatively turn raw information into a clear and interactive presentation, ensuring the branding and style is clear throughout.
- 7. Horizon scan for innovative initiatives, projects and activities contributing to each programmes' capacity, capability, and culture to continually improve and redesign the way it delivers services at pace.

What are Experts by Experience?

1. Experts by Experience are people who have personal experience of using services. They can also be a carer or family member for someone who uses (or has used) mental health services or social care services.
